Judul : Implementasi Sistem Penyimpanan Obat Berdasarkan Standar Pelayanan Kefarmasian Di Apotek Iboe Kecamatan Cinere Kota Depok

Penyimpanan obat merupakan sistem penyimpanan yang tepat dan baik akan menjadi salah satu faktor penentu mutu obat yang didistribusikan. Penelitian ini bertujuan untuk mengetahui seberapa besar implementasi sistem penyimpanan obat berdasarkan standar pelayanan kefarmasian di Apotek Iboe. Penelitian ini menggunakan rancangan penelitian non eksperimental dan bersifat deskritif. Penelitian ini dilakukan dengan cara mengobservasi langsung sistem penyimpanan di Apotek tersebut. Observasi langsung dilakukan dengan sistem check list menggunakan tabel pengamatan, kemudian dihitung persentase implementasi sistem penyimpanan berdasarkan standar pelayanan kefarmasian di apotek tersebut (Permenkes RI Nomor 73 tahun 2016). Hasil penelitian menunjukkan bahwa sistem penyimpanan berdasarkan standar pelayanan kefarmasian di apotek sesuai dengan persyaratan sistem penyimpanan obat dengan kategori baik (persentase penilaian 85,71%). Sarana, Prasarana dan Alat yang dimiliki Apotek Iboe dengan kategori baik(Persentase penilaian 75%). Pencatatan kartu stok dengan kategori cukup(Persentase penilaian 71,42%). Pengamatan mutu obat dengan kategori baik(Persentase penilaian 71,42%).

Title : Implementasi Sistem Penyimpanan Obat Berdasarkan Standar Pelayanan Kefarmasian Di Apotek Iboe Kecamatan Cinere Kota Depok

Drug storage is an appropriate and good storage system which will be one of the determining factors for the quality of distributed drugs. This study aims to determine how much the implementation of the drug storage system based on the standard of pharmaceutical services at the Iboe Pharmacy. This study uses a non-experimental research design and is descriptive in nature. This research was conducted by directly observing the storage system at the pharmacy. Direct observations were made with a check list system using observation tables, then the percentage of storage system implementation was calculated based on pharmaceutical service standards at the pharmacy(Permenkes RI Nomor 73 tahun 2016). The results showed that the storage system based on pharmaceutical service standards in the pharmacy was in accordance with the requirements for the drug storage system in the with good categories(Assessment percentage 85,71%). Facilities, Infrastructure and Equipment owned by the Iboe Pharmacy are in good category (Assessment percentage is 75%). Listing of stock cards with adequate category (Assessment percentage 71.42%). Observation of drug quality in good category (Assessment percentage 71.42%).
